

USA Volleyball National Events Housing Guidelines Candidate / Camper FAQs

Candidates for a National or Junior National Referee or National Scorer certification and Premier Campers are eligible for housing, but they must pay for their housing <u>in advance</u>. The following FAQs will help you understand these guidelines.

1. If I am a National Referee candidate at the 18s GJNC and will be participating in the evaluation process, am I eligible for housing?

Yes, but you will be required to pay for ½ the room cost for the 3 days during the evaluation session. The housing room will be shared with another referee (may or may not be another candidate). The candidate must pay for housing IN ADVANCE by the due date established by the Officials' Development Department.

2. If I am a Junior National Referee candidate and will be participating in the evaluation process (3 days) at the GJNC and will be attending the camp and/or officiating additional days at the tournament, am I eligible for housing?

If you are accepted to the training camp and/or to workdays before or after your evaluation session, you are eligible for housing. You will be required to pay for $\frac{1}{2}$ the room cost for the 3 days during the evaluation session. If you participate in the camp, you will also be required to pay for $\frac{1}{2}$ the room cost for the days of the camp. The candidate must pay for housing IN ADVANCE by the due date established by the Officials' Development Department.

3. If I am a Junior National Referee candidate or camper and will be participating ONLY in the evaluation or camp process (3 days) at the GJNC am I eligible for housing?

Yes, but you will be required to pay for $\frac{1}{2}$ the room cost for the 3 days during the evaluation or camp session. The housing room will be shared with another referee (may or may not be another candidate or camper). The candidate or camper must pay for housing IN ADVANCE by the due date established by the Officials' Development Department.

4. If I am a National Scorer candidate and not a National-level referee, am I eligible for housing at the Open National Championship?

Yes, but you will be required to pay for $\frac{1}{2}$ the room cost for the two nights of the evaluation session. The housing room will be shared with another official (may or may not be another candidate). The candidate must pay for housing IN ADVANCE by the due date established by the Officials' Development Department.

5. If I am a National Scorer candidate and a current National-level referee, and I referee at the tournament for 3 or more days and am evaluated on 1 day, am I eligible for housing?

Yes, you are eligible for housing, as long as you are in attendance for a minimum of 4 days and are available with no conflicts on the days you will be refereeing. You will be required to pay for ½ the room cost for the one night of the evaluation session.

6. If I am a National Scorer candidate and a current National-level referee, and I referee for 1 or 2 days of the tournament and am rated on 1 day, am I eliqible for housing?

Yes, but you will be required to pay for ½ the room cost for all days you attend the tournament since you do not meet the minimum number of days required for housing. The housing room will be shared with another official (may or may not be another candidate). The candidate must pay for housing IN ADVANCE by the due date established by the Officials' Development Department.

7. How do I register for housing if I am eligible?

When you register for the tournament in AES, you will have the option to request housing.

Summary:

- All candidates who choose to participate in housing must pay for housing IN ADVANCE by the due date established by the Officials' Development Department.
- National Referee candidates at the 18s GJNC are eligible for housing, but the candidate will be responsible for ½ the room cost during the evaluation session.
- Junior National Referee candidates at the GJNC are eligible for housing. The candidate will be responsible for ½ the room cost for the three nights of the evaluation session. If you attend the camp, the candidate will be responsible for ½ the room cost for the nights of the camp.
- National Scorer candidates are eligible for housing at the Opens if they are also a National-level referee and are available for a minimum of 4 consecutive days at the event, with their 1 day of the evaluation process being included in that number. The candidate will be responsible for ½ the room cost for the one night of the evaluation session. National-level referees who are in attendance for less than 4 days will be responsible for ½ the room cost for all nights in attendance.
- National Scorer candidates at the Opens are eligible for housing even if they are not a National-level referee. The candidate will be responsible for ½ the room cost for the two nights of the evaluation session.
