

WHAT IS ONLINE CSEA?

Online child sexual exploitation and abuse (CSEA) is a horrific crime that targets some of the most vulnerable people in our communities – our children and teens. It includes a broad range of criminal acts that involve the victimization of a minor for sexual gratification or some other personal or financial gain.

DHS' Homeland Security Investigations (HSI) is a global leader in combating online CSEA. Know2Protect™ relies on the expertise and authority of HSI special agents tasked with finding online predators and bringing them to justice. Despite the collaborative work with key partners, online CSEA is growing at an alarming rate and HSI cannot investigate and arrest its way out of this crisis. The goal of Know2Protect is to increase national awareness of this crime and share preventative strategies to stop future victimization.

THE THREAT

The National Center for Missing & Exploited Children (NCMEC), the nation's clearinghouse for child sexual abuse material, received more than one million reports for the first time in 2014. Since then, the numbers have increased at an alarming rate.

FACTS AND FIGURES

Our expanding digital world and increased connectivity provides more opportunities for predators to exploit and abuse our children and teens. Because this crime occurs all over the world, it has become a global epidemic and requires a bold response.

In FY 2022, HSI arrested 4,459 individuals for crimes involving the sexual exploitation of children and helped secure MORE THAN 2,100 CONVICTIONS.

TOP TEN TIPS FOR PARENTS AND TRUSTED ADULTS

Online CSEA can feel overwhelming and beyond your control. However, everyone can play a role in helping to stop this crime. It starts with understanding the threats, taking preventative measures, and spreading the word.

- Create a dialogue with your child for open two-way conversations.
- 2. Password protect or control access to your child's app store and gaming downloads.
- Set time and area limits for use of devices. Set device check-in times.
- 4. Set all apps, games, and devices to private.
- Turn off location data services for social media and nonessential apps.
- 6. Talk about the permanency of data. Online data can last a lifetime.
- 7. Create contracts with your child regarding online behavior.
- 8. Know your child's friend lists and remove any strangers.
- Your child should never leave a game to chat with someone they don't know on a different platform.
- 10. Do not delete messages or images from predators.

 Save usernames, screenshots, and images as evidence.
